Basis for the order

The vehicle inspection takes place in a disassembled state.

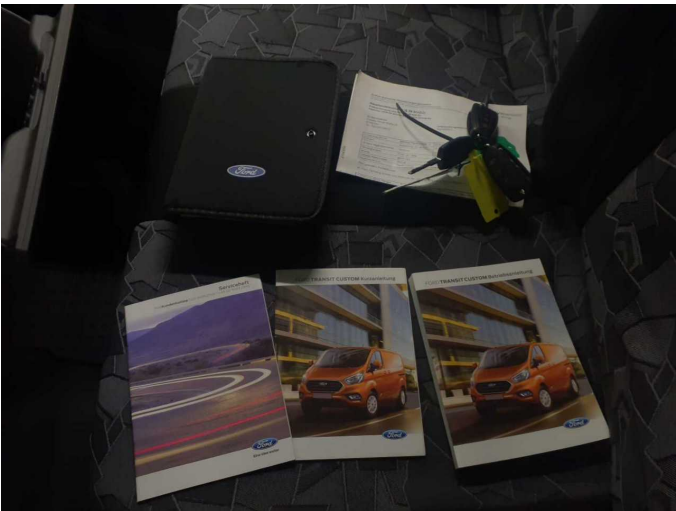


Figure 13: Documents

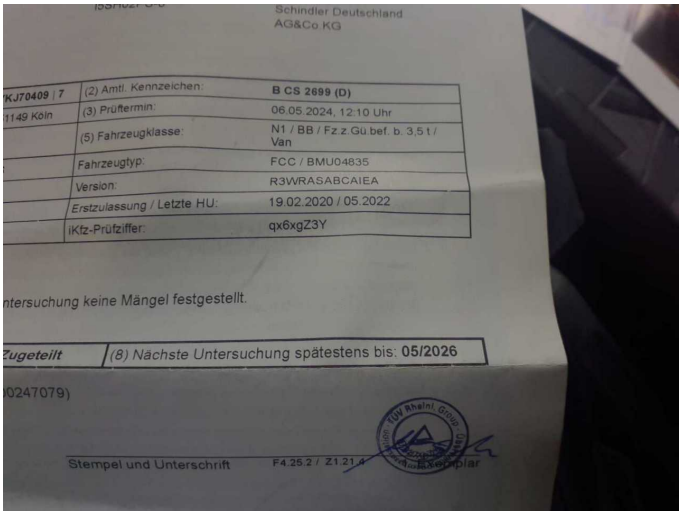


Figure 14: Documents

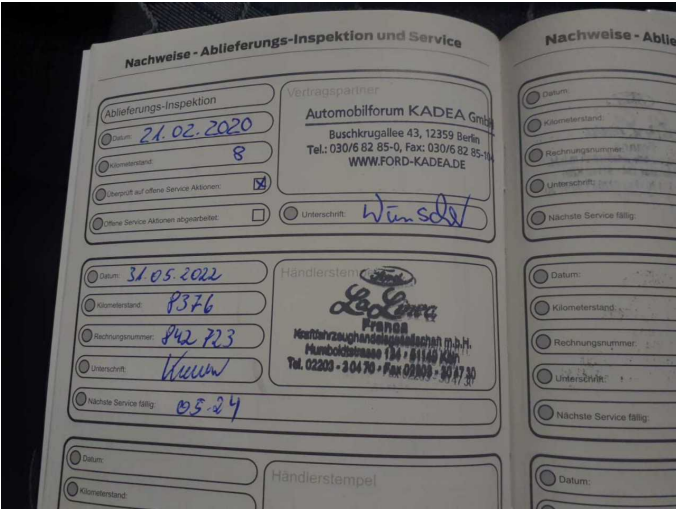


Figure 15: Documents

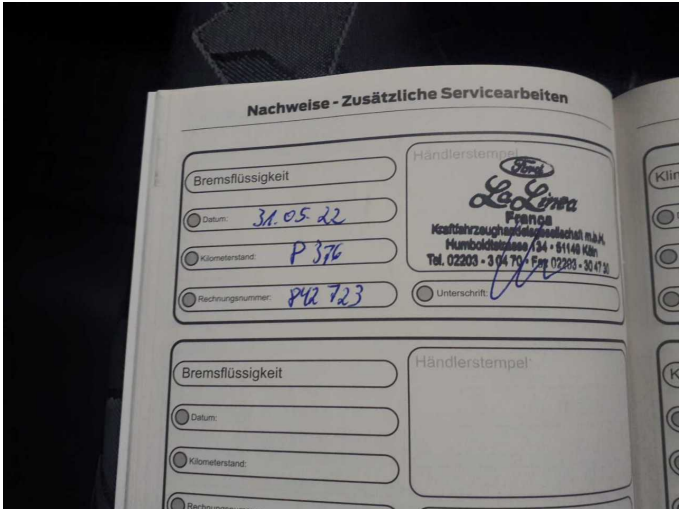


Figure 16: Documents

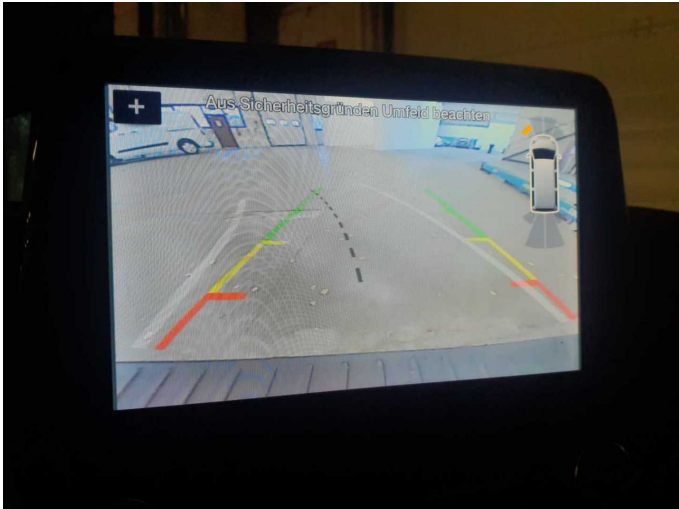


Figure 22: Misc.

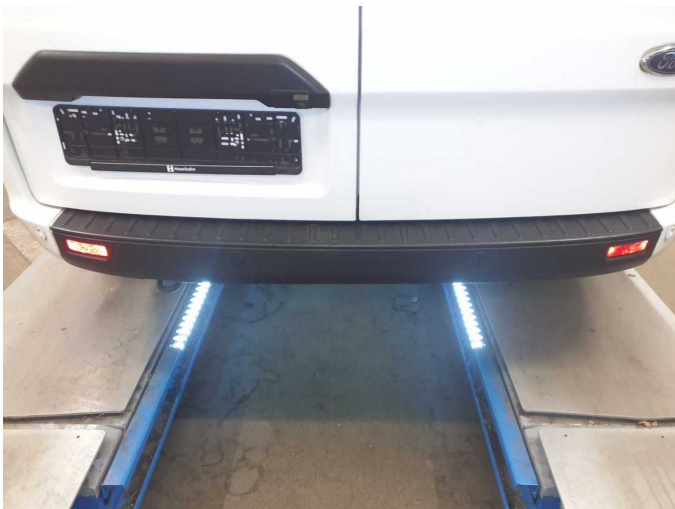
Figure 26: Misc.



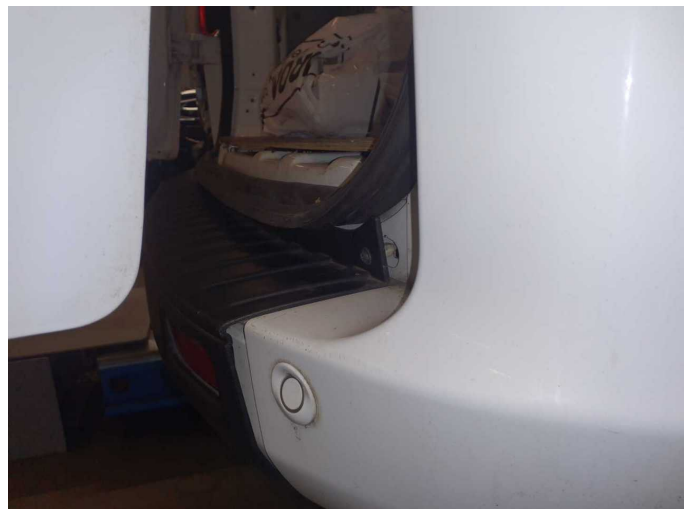
Figure 27: Misc.

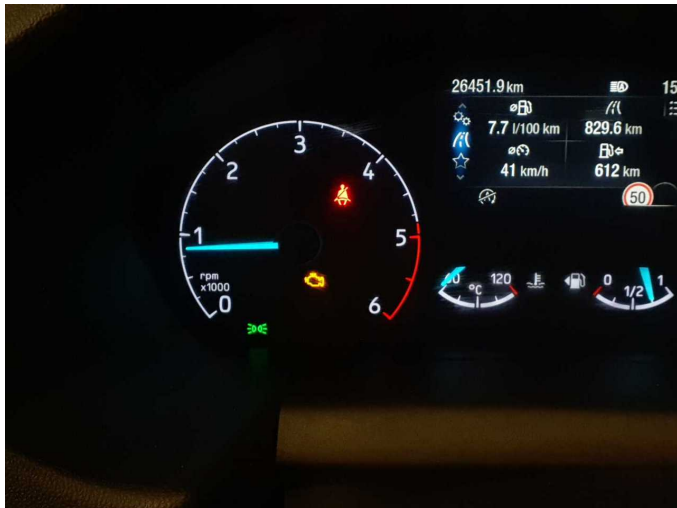
